



# PPGA Father-Son Championship

## Sunday, May 19, 2019

### Twin Ponds Golf Club



**Eligibility:** Entries are open to all amateur golfers, regardless of handicap or golf club. Teams must be comprised of a father and a son. There will also be divisions for other parent/child combinations (father/daughter, mother/son, mother/daughter). Entries are subject to approval or rejection anytime (either before or during the Championship) by the PPGA Championship Committee. The committee decisions shall be final in all rulings. The May 15 handicap revision will be used for the net competition.

**Entrance Fees:** The entry fee is \$150.00 per team to play gross or net (includes greens fees, tournament prize pool and buffet dinner after golf), \$180 per team to play both gross and net. Walking is permitted. No refunds will be granted for cancellations received after the closing date.

**Entries close May 10, 2019 in the Association office. No entries will be accepted after the deadline.**

**Pairings and Tee Times:** This tournament will be a 1:30 shotgun start. All contestants should check-in by 1:00 and be prepared to go out to their starting hole by 1:15. A contestant who has not canceled his entry by written or verbal notification to the association office may be subject to disqualification for this event and subsequent events of the association. Starting groups/holes will be posted to the website [www.phillypublinks.com](http://www.phillypublinks.com) and contestants will be notified by e-mail prior to the event.

**Competition:** The PPGA Father-Son Championship will be played over 18 holes of alternate-shot, chapman format (Chapman Format is both players drive, both players hit second shots from their partner's drive, then select a ball to play and alternate playing until the ball is holed). The father-son teams will be divided into two divisions, sons 18 years of age and under and sons 19 years of age and older. **In the event of a tie for the lowest score, a sudden-death playoff will be held following the conclusion of play.** All other ties will be broken by the USGA method.

**Awards Presentation:** Gift Certificates and crystal will be awarded depending on the size of the field.
